HIV Infected?

You still retain your rights!



At the hospital

Testing must be voluntary and you can refuse to be tested.

You have to be counselled before testing and after obtaining the results.

The hospital staff cannot:

- Refuse to treat you solely on the ground of your HIV status;
- Treat you differently because of your HIV status;
- Disclose your status without your consent to anyone, including your employer.





At work

You have a right to privacy and you are not obliged by law to disclose your HIV status to your employer.

An employer or prospective employer cannot:

- Unfairly discriminate against you on the basis of your HIV status;
- Deny you employment on the basis of your HIVstatus;
- Ask questions to find out whether you have HIV/ AIDS:
- Require you to undergo an HIV test, before or during employment.

Testing at the workplace is allowed as long as it is **anonymous**, **voluntary** and your **consent** has been obtained.

You **cannot be dismissed** on the basis of your HIV status unless you are no longer physically able to work and fair procedures have been followed.



Social Assistance

In the event that you are no longer physically able to work and cannot generate your own income, you may become eligible for financial assistance from the government.

The Department of Welfare will provide you with benefits if you have a CD4 count below 50 and a major opportunistic infection. You may still qualify if you don't meet these conditions but you are no longer able to work.

These are the requirements:

- 1) you have to be a South African citizen
- 2) you must have a medical report confirming your physical condition
- 3) there must be no-one within your immediate family who can support you
- you cannot be living in a government run facility for example a prison or care and treatment centre
- 5) you cannot be the recipient of any other social grant

You need to produce the following documents:

- 1) an Identity Document (ID)
- 2) proof of income or assets (possessions) —including those of your spouse
- 3) proof of marital status
- 4) a letter from a doctor
- 5) any other medical records.

You or someone acting on your behalf can apply at your nearest Department of Welfare or Pension Office (see contact details below) It usually takes three months for your application to be processed. Remember all your information remains confidential.
