**OFFICIAL RESULTS**

**A. END OF PRELIMINARY ROUNDS**

The following results are based on the team performances in the preliminary rounds where teams argue the hypothetical case separately in English, French or Portuguese.

**1. TOP TEAMS**

**1.1 TOP 5 LUSOPHONE TEAMS**

The top 3 lusophone universities from the preliminary rounds are:

- In 3<sup>rd</sup> position – Universidade Agostinho Neto, Angola (64.04%)
- In 2<sup>nd</sup> position – Universidade Catolica de Angola (68.09%)
- **The best lusophone team from the Preliminary rounds: Universidade Eduardo Mondlane, Moçambique (79.53%)**

**1.2 TOP 5 FRANCOPHONE TEAMS**

The top 5 francophone universities from the preliminary rounds are:

- In 5<sup>th</sup> position Université Libre de Matadi (69.75%)
- In 4<sup>th</sup> position Faculté Universitaires Privées d'Abidjan, Côte d'Ivoire (70.80%)
- In 3<sup>th</sup> position. Université Abdou Moumouni de Niamey, Niger (71.63%)
- In 2<sup>th</sup> position. Université Libre de Kinshasa, RDC (74.10%)
- **The best francophone team from the Preliminary rounds: Université des Lagunes CIDD, Côte d'Ivoire (79.28%)**

**1.3 TOP 10 ANGLOPHONE TEAMS**

- In 4<sup>th</sup> position: University of Mauritius (74.60%)
- In 3<sup>rd</sup> position: University of the Gambia (75.90%)
- In 2<sup>nd</sup> position: Moi University, Kenya (77.36%)
- **The best Anglophone team from the Preliminary rounds: University of Stellenbosch, RSA (79.31%)**

## **2. BEST MEMORIALS**

Teams, composed of 2 students, receive a joint score for their written memorials in the preliminary rounds. The winners of the best memorials prize are the teams with the highest team score for the written memorial in each language group in the preliminary rounds.

### **2.1 LUSOPONE**

The best team memorial, written in Portuguese:

- Universidade Eduardo Mondlane (Mozambique) 75.50%

### **2.2 FRANCOPHONE**

The best team memorial, written in French:

- Université des Lagunes CIDD, Côte d'Ivoire 79.28%

The best team memorial, written in English:

- Rhodes University, RSA 85.50%

## **3. BEST ORALISTS**

Students are scored individually for their oral presentations in the preliminary rounds. The best oralist is the student with the highest individual score in each language group in the preliminary rounds.

## **B. END OF FINAL ROUND**

In the spirit of collaboration and cooperation, and also to bridge artificial colonial language and other divides, the best 2 English, French and Portuguese-speaking teams from the Preliminary Rounds are combined to form two new joint teams: one English, one French and one Portuguese-speaking university on each side. They work together to consolidate their arguments and present one joint case, for the Applicant or for the Respondent. This special mechanism also ensures to temper the fierceness of the Competition, and to encourage participating universities to enjoy the interaction and not become too obsessed with simply the results.
