VISA APPLICATION

OFFICIAL PASSPORT

- Mission letter
- Original and a copy of the yellow fever vaccination certificate.

TOURIST AND BUSINESS VISA

1	A valid passport which expires in no less than six (6) months with two blank pages and a copy of the first page of the passport.
2	One individual visa application form filled and signed by the applicant (copies, errors, alterations, omissions, inappropriate signature will be subject to refusal).
3	Two recent color ID photos.
4	An invitation letter from the correspondent in Côte d'Ivoire (company or individual), with his (her) name, surname, address, and contact numbers as well as the visit purpose, that letter must be certified by the town council in Cote D'Ivoire plus the ID copy of that individual. (Invitation letter must be written in FRENCH)
5	Proof of sufficient financial mean available (not older than 3 months) of the host in case he/she is the one inviting and accommodating the applicant. If the applicant is taking full responsibility of its journey: a bank statement not older than three months is require and a copy of ID.
6	Employment letters translate in FRENCH
7	A hotel reservation or a legal accommodation certificate or a written undertaking from the host stating that he/she is accommodating the applicant (certified by the town council of the correspondent's city and in French).
8	A plane ticket reservation.
9	Original and a copy of the yellow fever vaccination certificate.
10	For children, attach the following documents:

	<ul style="list-style-type: none"> - Legal parental authorization from one parent (the parent who is NOT travelling) if the child is travelling with one of the two parents; or legal authorization from both parent if kid is traveling alone. - Birth certificate. - Proof of registration letter from a learning institution, where applicable.

NB:

- 1- Visas issued by the Embassy cannot exceed a validity period of 30 days except South African citizen who can be granted three (03) months visa.
- 2- The visa application is processed within a period of one week (07) working days.
- 3- Rejection of application are not subject to any explanation or justification.

- 5- If you are not a South African citizen, please check the visa fee on the attached price list.
- 6- Visa fee varies according to the country of origin, for South African passport holders the visa cost is:

Transit	: R500.00
One entry (3 days – 1 month)	:R700.00
Multiple entries (3months)	:R1200.00
